

Central Coast Holiday Parks – 'Subscriber Giveaway' Competition

Terms and Conditions

1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is open to all Australian residents aged 18 years and older.

2.2 Employees of Australian Tourist Park Management (ATPM), NRMA, Central Coast Council and associated park and resort managers, park employees and their immediate families are not eligible to enter. Employees of all divisions of Central Coast Holiday Parks and their immediate families are not eligible to enter. Immediate family means: spouse, ex-spouse, de-facto spouse, child or step-child (whether by natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

3. HOW TO ENTER

3.1 The competition commences at 9am on 4th February 2022 (AEDT) and concludes at 4pm on 6th February 2022 ('the competition period').

3.2 To enter the competition, entrants must enter the required details into the appropriate form on ATPM iPads. Only one entry per person is permitted.

4.1 A total of one prize will be awarded at the end of the competition period. The draw will take place on 11th February 2022. Winner will be notified by via email within 7 days after the competition has been drawn.
